## NPSO 2000 State Office Candidates

The Nominating Committee offers the following list of candidates for state offices. Election ballots will be included in the March *Bulletin*.

#### PRESIDENT

Bruce Newhouse, incumbent, was born in Oregon and fell in love with our native flora and fauna while growing up in the Portland suburbs and northern Oregon Cascades. He is a botanist, wetland scientist, and naturalist as a partner in Salix Associates. Since the early '90's he has been active in NPSO, serving stints as Emerald Chapter president, vice-president, and co-chair of NPSO's Rare and Endangered Committee. He is an at-large board member and the NPSO Statewide Atlas Coordinator for the Oregon Flora Project. Bruce is on the Atlas Committee, is a member of the Carex Working Group, and is a member of several local parks and storm water committees. He is an adjunct faculty member at the University of Oregon, co-teaching an urban habitat class in the Landscape Architecture Department. Bruce has worked to stimulate interest and activism in NPSO, particularly in building educational resources and providing input to public decision-making. He believes that as concerned, local residents we are the only stewards of our local ecosystems, and that we need to be more vocal and visible in that role.

#### VICE PRESIDENT

Michael McKeag, incumbent, is a member of the Portland Chapter. His involvement with NPSO grew out of his interest in gardening with native plants. After a few field trips and a season as field trip coordinator for the Portland Chapter, he was hooked. Now his garden languishes while Michael is off in the wilds studying plants in their native habitat. He hopes to participate in an NPSO galvanized with a sense of purpose that inspires others to join in. He would like to see NPSO become irresistible.

#### **SECRETARY**

Rhoda Love, incumbent, of Eugene has been an NPSO member since 1972. She is a past state president of our Society and is a past copresident of the Emerald Chapter. Rhoda taught botany at Lane Community College for approximately 30 years. Now retired, she volunteers for the Oregon Flora Project in Corvallis and works on biographies of Northwest Plant Hunters.

#### TREASURER

Eric Wold is a member of the Emerald Chapter. He enjoys botanizing and mushroom hunting with NPSO and landscaping his yard with plants native to the southern Willamette Valley. Eric is a natural resources planner for the City of Eugene, where he works on wetland conservation and Endangered Species Act issues. Prior to that, he worked as a wildlife biologist with the Willamette National Forest. Eric has an M.S. in ecology and evolutionary biology from the University of Missouri-St. Louis, and a B.S. in biology from Lewis and Clark College.

#### DIRECTORS AT LARGE

Karl Anderson studied Genetics at the University of Wisconsin, Madison (his home town), then went on to a Master's Degree in Environmental Science at Washington State University, in Pullman, WA. Following that, he aspired to an academic career in Ecology and Evolution, but two years of doctoral work dissuaded him; instead, he became a Computer System Administrator. After a sojourn in the Washington, DC, area, he returned to the PNW, and eventually joined the computer support staff at the U.S. Environmental Protection Agency's Western Ecology Laboratory, in Corvallis. As he came to know the native plant communities of the Willamette Valley, he

learned how much has been lost, and decided to dedicate himself to their conservation and restoration. He has found the members of NPSO to be kindred spirits, and would be honored to serve on the Board.

Dan Luoma is an Assistant Professor in the Department of Forest Science at Oregon State University. Dan was a founding member of the Corvallis Chapter and has served the Society in many capacities since that time. He Chairs the Budget Committee and the Field Research Grants Committee and was appointed by the Board to finish Kathleen Cheap's term as a Director-at-Large. At the state level, he has previously been Vice-president, Immediate-past President, President, and Director-at-Large. He is currently Treasurer of the Corvallis Chapter and has served as chapter President and Vice-president.

Steve Northway is a member and immediate past president of the Corvallis Chapter and president of SEM, Inc. He has a resolute interest in the true conservation and recovery of our native ecosystems and species. He has worked to gain the cooperation of numerous agencies (Benton County Public Works, USDA Natural Resource Conservation Service, ODOT, etc.) in the preservation of our threatened and soon-to-be-threatened species. Our Willamette Oak Savanna ecosystem counts as one of the most endangered in North America and Steve has paid special attention to its plight and have studied the requirements of a number of its vanishing endemic plant species. He has held public education and recovery events attended by hundreds of community members to stimulate awareness of the need for conservation of their rapidly declining populations and of their associated insect companions. He believes this awareness is pivotal and is something that the Society should be deeply engaged in disseminating since extinction is something that only you can prevent. He lives in the eastern foothills of the

Coast Range with the coyotes and about 150 native plant species in his front yard, including a number of threatened ones, that have prospered and increased over the years under my carefully managed scientific neglect.

## Grant Proposals Requested

The Native Plant Society of Oregon will continue to sponsor small field research grants. The objectives of the program are: 1) to stimulate basic field research into the biology and distribution of Oregon's native and naturalized flora and vegetation, particularly in the more remote areas of the state, and 2) to promote native plant conservation through better understanding of Oregon's flora and vegetation and the factors affecting their survival. There should be at least three people, or couples, who can participate regularly in this task, so that no one needs to do the job more than once in three months. This also allows

scheduling flexibility.

The monthly task requires picking up the printed Bulletins from the printer in southeast Portland, adding two tape seals to each, attaching address labels, and delivering filled mailing trays to the Portland Post Office (Hoyt Street Station). This activity occurs about the third week of each month; a commitment to timeliness is essential.

If volunteers cannot be found for this task, NPSO will have to contract with a commercial mailing company. This will cost NPSO about \$2,000 per year. For this amount of money, NPSO could fund, jointly with Oregon Department of Agriculture, an additional summer internship for research on Oregon flora, or a variety of other activities. ## Remembering Leighton Ho (1951-1987)

NPSO member, Dr. Leighton Chee Won Ho, died in a tragic drowning accident on the island of Kauai, Hawaii on December 20, 1987.

Leighton was President of Emerald Chapter in 1983 - 1985, helping our chapter become involved in important environmental issues including the fight to establish the Waldo Lake Wilderness, conservation of rare species such as *Aster vialis*, and protection of fragile ecosystems especially along the coast.

Leighton loved Oregon and NPSO. He was born in Hawaii but attended college here. His specialty was mycology. He earned a BS at OSU in 1973 and a PhD at UO in 1980. Scott Sundberg, Oregon Flora Project Coordinator, recalls that he got his first taste of

plant systematics at the UO in 1975 with Leighton as his lab instructor. Leighton was a high school biology teacher in Hawaii at the time of his death. Contributions from his many friends and from his bereaved parents helped to establish the NPSO Leighton Ho Memorial Fund at that time. We opened a special account with contributed funds and the interest they accrued dedicated to awarding each year a Leighton Ho Field Botany Award for summer research.

The first recipient of the Ho Award was Jenny Lippert of Eugene, who used the \$400 stipend to study *Sidalcea cusickii* in southwest Oregon. The second year's award was to Robert Misley of Clackamas Community College who studied Delphinium leucophaeum. Recent awards have gone to Scott Jackson to *study Erigeron decumbens*, to Esther McEvoy and Ayn Whytemare to study *Sidalcea hirtipes*, to Kimberly Davis to study Willamette Valley wet prairies. Last summer's Leighton Ho award went to Susan Nyoka of Southern Oregon University to study pollination in *Darlingtonia californica*.

In 1990, 3 years after Leighton's death, the Ho fund contained over \$2,000 and earned approximately \$100 in annual interest.
Unfortunately contributions began to decline in 1995. We contributed only \$200 this past year. Unless The Ho Fund receives a new influx of cash, it will soon no longer be able to cover the granting of the annual \$400 stipend.

I am writing a check to the Leighton Ho fund today and hope that many *Bulletin* readers will follow my example. I feel certain that Leighton's many friends as well as former recipients of the Ho Award will want to contribute, and I hope other NPSOers will as well. I know Leighton's widowed mother in Hawaii will be cheered to learn that this fund is alive and well and that Leighton has not been forgotten by the organization he loved. Send

## Endangered Status Determination for Fritillaria gentneri

The Fish and Wildlife Service published a final rule determining endangered status for Frillaria gentneri (Gentner's fritillary) on December 10. NPSO has been active in seeking protection for this species. The agency's summary of the decision follows:

"We, the U.S. Fish and Wildlife Service (Service), determine endangered status under the Endangered Species Act of 1973, as amended (Act), for *Fritillaria gentneri* (Gentner's fritillary) (= Mission-bells). This plant is found only in two counties, Jackson and Josephine, in southwestern Oregon. This taxon is threatened by residential development, agricultural activities, logging, road and trail improvement, off-road vehicle use, collection for gardens, and problems associated with small population size: This rule implements the Federal protection and recovery provisions afforded by the Act for *Fritillaria gentneri*."

EFFECTIVE DATE: This final rule is effective January 10, 2000.


