Poster Contest Rules:

Photos will be rated and selected by the poster committee based on subject matter, composition, and technical excellence. The poster designer has sole discretion of not using an image should it not work into the overall layout or is deemed to not be of satisfactory quality. The selected photographer(s) must be able to provide a high-resolution and preferably unedited image (at least 300 dpi) version of the image. All photographers who submit photos to be considered for the poster give consent for NPSO to reproduce the submitted images free of charge for our poster, website, social media, and related publicity material. - Native Plant Appreciation Month Committee

Important NPSO Membership Reminders and Updates

Dear NPSO Membership,

As NPSO continues to work to improve our systems to serve membership and support the amazing volunteers who run them, we have some reminders and updates for you as we approach the new year.

Membership Rate Changes: This is a reminder that our membership rates and levels were updated for 2025. Please look carefully at the new options as you renew. Consider choosing "automatic renewal" to never miss your renewal! Also notice our budget friendly options of "student" and "living lightly."

New "Rolling Membership": We have traditionally operated on a calendar year membership renewal. As of 2026, each member's renewal cycle will be based on when they sign up or renew. Existing members will be assigned a renewal date between January and February. This will remove the holiday crunch for our hard-working volunteers. Members will receive reminders at renewal time and a grace period beyond their renewal date.

New Organizational Membership: For the first time we have an Organizational Membership level for our business and organizational partners! Each organizational membership comes with two memberships for their representatives.

Membership Chair Needed: NPSO is seeking a volunteer Membership Chair to help strengthen our growing community. This role is an opportunity to support chapters and members and improve how we connect across the state. If you enjoy helping people feel they are part of something meaningful, this position offers a chance to make a tangible impact on NPSO's future. New Opt-In Email Categories for Conservation and Legislative Alerts: NPSO is committed to keeping members informed about issues that affect Oregon's native plants, while also being respectful of members' inboxes. Some conservation and legislative matters require rapid action and cannot wait for the deadlines of the *Bulletin*, so the NPSO state board has approved two new opt-in email categories for time-sensitive alerts.

Beginning with this year's membership renewal, members will have the option to subscribe to:

- Conservation alerts
- Legislative alerts

These categories will be used sparingly. Members who choose not to opt in will continue to receive regular NPSO communications but will not receive these rapid response messages.

Members may change their choices at any time - either opting in or opting out - by logging into their member profile on Wild Apricot and updating their email preferences. Watch your email in December for a tutorial on how to do that.

We hope these new options will help NPSO share important conservation and policy information more effectively, while giving every member control over what types of messages they receive.

OregonFlora

Along with completing the writing and artwork that will comprise the final volume of the printed *Flora of Oregon*, our team is also maintaining the <u>oregonflora.org</u> website. It is our digital *Flora*, augmented with interactive tools, maps, and images to give you accurate information that addresses your needs. We recently updated the thumbnail distribution maps on 5,592 plant profile pages and added approximately 2,000 new field photos this calendar year. We also continuously add new plant specimen data from herbaria throughout the western United States; one of the benefits of being a Symbiota portal is our ability to exchange such



information. A new edition of the vascular plant checklist will be published online in January 2026, capturing taxonomic changes finalized in the upcoming Volume 3 and in the scientific literature.

Oregon Mystery Plant

Last Month's Mystery Plant Revealed

Congratulations to Willow Elliot, Steve Sheehy, Kristi Mergenthaler, Julie Kierstead, khcritters, and Jess Bechemumin. They all correctly identified the November Mystery Plant as *Raillardella argentea*, silky raillardella. This perennial herb is in the Asteraceae family. *Flora of Oregon*, Volume 2 describes its habitat as "dry, open, gravelly sites in conifer forests, semi-barren subalpine and alpine slopes, and flats. In Oregon it is found in the Cascade and Siskyou Mountains. It is also found in California and Nevada. Its range in Oregon overlaps with the very rare in Oregon *Raillardella scaposa* (the only other *Raillardella* described in *Flora of Oregon*), but the two species are not known to occur together.



New This Year: A Special Webinar

For this Id-a-thon, one of those identifiers profiled, <u>Jess Beauchemin</u>, is hosting a webinar: "Curiosity to Connection: Exploring Oregon native plants One ID at a Time." She will talk about the benefits of making identifications on iNaturalist (for science and for the identifier), how everyone, regardless of current knowledge and skill level, can contribute IDs and make connections with other native plant enthusiasts through iNat and NPSO. We will provide date and time of this webinar soon through NPSO media and at the <u>Flora of Oregon: Vascular Plants's Journal · iNaturalist</u>. You do not have to have an iNaturalist account to access the Journal or attend the webinar; you do need to have an iNaturalist account for ID-a-thon participation

What do we want from you?

We are asking you to add identifications to as many "Needs ID" plant observations for Oregon as possible, with a goal of reaching 24,500 identifications. You don't have to be an expert botanist to participate; in fact, we encourage everyone, regardless of your level of botanical expertise, to contribute. Every observation you help identify - whether it's a trillium, lupine, or Douglas-fir - strengthens the scientific record. One of our goals for these events is to increase the number of people who identify Oregon plants on iNaturalist.

Why it matters

The Flora of Oregon: Vascular Plants iNaturalist project currently has 1,257,782 observations of 5230 plant species from across Oregon. An amazing 65% are RESEARCH Grade, verified by several different individuals as accurate; however, 35%; 438,752 observations, are in the Needs ID category and that is where your participation comes in. Even adding accurate identification to some of our most familiar and iconic species would go a long way towards contributing to conservation and biodiversity research data by increasing the accuracy of observations. You may learn more about the geographic distribution and flowering times of plant species that have captured your interest. And this might inspire your next native plant outing in 2026!

NPSO 2025 Strategic Planning Session: Charting a Sustainable Future

The Native Plant Society of Oregon held its 2025 Strategic Planning Session this October 17- 19 at the Siskiyou Field Institute in Selma, Oregon, bringing together fourteen board members, chapter presidents, and committee leaders for a focused weekend of assessment and goal setting. The purpose of the session was to identify strategic goals that will strengthen NPSO's long-term sustainability, support volunteer capacity, and clarify the organization's conservation role as it prepares for its next phase of growth.

The three-day process, facilitated by Rachel Werling, combined large-group conversations, small-group exercises, and consensus-based decision-making. Each component of the session identified related goals for the organization. Participation in these goal-working groups is welcome, and details and invitations will be coming soon.

The session opened with a review of member and board survey findings from 2024, followed by a SWOAR (Strengths, Weaknesses, Opportunities, Aspirations, Results) assessment. This exercise helped establish a shared understanding of the Society's current condition and framed the weekend's work. The SWOAR discussions highlighted several core strengths, including NPSO's strong conservation ethic, deep botanical

expertise across its membership, and solid financial footing. Participants also acknowledged ongoing challenges such as volunteer shortages, declining leadership capacity in some chapters, and the need to strengthen diversity and inclusion. Opportunities identified included expanding collaboration with tribes, universities, and community partners, as well as developing additional conservation and educational initiatives.

The SWOAR session ultimately identified five priority goals: increasing botanical education, developing gardening education initiatives, improving board mentorship, enhancing inclusivity efforts, and strengthening volunteer-driven rare plant monitoring.

Mission and vision discussions affirmed NPSO's long-standing focus on the study, enjoyment, and conservation of Oregon's native plants. Participants continued refining draft vision and values statements to better reflect the organization's commitment to science-based education, inclusivity, and public engagement.

A significant portion of the weekend explored NPSO's conservation role. The group clarified that NPSO's public voice should remain science-based, nonpartisan, and educational. Participants emphasized the importance of constructive communication, partnership with agencies and community groups, and clear internal processes for reviewing conservation-related statements. A key outcome was the recommendation to expand the Conservation Committee to include multiple members, ensuring shared responsibility for review, coordination, and communication.

Organizational structure and capacity were also central themes. Participants examined the strengths and limitations of NPSO's current federated model (more on this later) and reviewed structures used by peer organizations. There was broad interest in exploring hybrid approaches that could improve coordination, efficiency, and chapter support while maintaining local identity. Strengthening the Chapter Round Table was identified as an important next step in improving communication and shared problem-solving across the Society.

Recognizing the limits of an all-volunteer structure, the group explored options for part-time staffing or contracted support. Participants identified financial management, administrative coordination, and membership support as areas where added continuity would be most beneficial. Priorities include defining an initial staffing role, developing the fundraising capacity needed to sustain it, and assessing Customer Relationship Module systems to improve membership and communications management.

On Sunday, participants synthesized and ranked strategic goals, identified potential champions, and outlined next steps. The board will continue the work of refining these goals, establishing clear metrics, and communicating outcomes to chapters and members in early 2026.

The 2025 Strategic Planning Session strengthened shared understanding, clarified NPSO's direction, and set forward-looking goals that position the Society to continue its mission—studying, enjoying, and conserving Oregon's native plants—well into the future. -Rachel Werling

Small Field Grant Proposals Requested

The NPSO will continue to sponsor small field research grants. The objectives of the program are: 1) to stimulate basic field research into the biology and distribution of Oregon's native and naturalized flora and vegetation, particularly in the more remote areas of the state; and 2) to promote native plant conservation through better understanding of Oregon's flora and vegetation and the factors affecting their survival.


NPSO State Board Meeting Highlights November 15, 2025

The Northwest Plant Materials Program at the Institute for Applied Ecology collects seed from a variety of native plants for a wide array of projects. The results are trickling in from our NPSOPDX25 Non-Native November BioBlitz focused

on naturalized, non-natives, and noxious plants in our backyards, parks, and neighborhoods. One hundred forty nine species have been submitted (not bad for 345 observations), and the month is only half over. Just a reminder that our iNaturalist Observations go into a larger database that many scientists and organizations use on a regular basis. Our own Jason Clinch had recently posted some garlic mustard observations, and almost immediately was contacted by the East Multnomah Soil and Water Conservation District to verify a new sighting. Community Science is important to all, and NPSO members can be a part of the good work being done to protect our native plants.
